

## PRIVACY POLICY

This privacy policy applies between you, the user of Freelance Corner, and Freelance Corner Ltd, the owner and provider of this website. We take the privacy of your information very seriously. This privacy policy applies to your use of any of our services and products, and all data collected by us or provided by you in relation to your use of the website.

### PLEASE READ THIS PRIVACY POLICY CAREFULLY

#### DEFINITIONS AND INTERPRETATION

1. In this privacy policy, the following definitions are used:

<b>Data</b>	Collectively, all information that you submit via the website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws.
<b>Cookies</b>	A small text file placed on your computer by this website when you visit certain parts of the website and/or when you use certain features of the website. Details of the cookies used by this website are set out in the clause below ( <b>Cookies</b> ).
<b>Data Protection Laws</b>	Any applicable law relating to the processing of personal data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK.
<b>GDPR</b>	The General Data Protection Regulation (EU) 2016/679.
<b>We or us</b>	Freelance Corner Ltd, a company incorporated in England and Wales with registered number 12174904. The registered office for Freelance Corner is Heron House, 10 Dean Farrar Street, London, SW1H 0DX.
<b>UK and EU Cookie Law</b>	The Privacy and Electronic Communications (EC Directive) Regulations 2003, as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011.
<b>User or you</b>	Any third party that accesses the website and is not either (i) employed by and acting in the course of their employment by Freelance Corner Ltd or (ii) engaged as a consultant or otherwise providing services to Freelance Corner Ltd and accessing the website in connection with the provision of such services.

2. In this privacy policy, unless the context requires a different interpretation:
- the singular includes the plural and vice versa;
  - references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - "including" is understood to mean "including without limitation";
  - reference to any statutory provision includes any modification or amendment of it;
  - the headings and sub-headings do not form part of this privacy policy

## SCOPE OF THIS PRIVACY POLICY

3. This privacy policy applies only to the actions of Freelance Corner and users with respect to this website. It does not extend to any websites that can be accessed from this website including, but not limited to, any links we may provide to social media websites.
4. For purposes of the applicable Data Protection Laws, Freelance Corner is the "data controller". This means that Freelance Corner determines the purposes for which, and the manner in which, your data is processed.

## DATA COLLECTED

5. We may collect the following data, which includes personal data from you at sign-up:
  - a. Name
  - b. Date of birth
  - c. Profession
  - d. Contact information such as email addresses and telephone numbers
  - e. Interests and specialisms
  - f. Additional fields are optional

In each case, in accordance with this privacy policy, these data fields may be subject to change in line with legitimate interest for providing products and services.

It is at your discretion to link your LinkedIn with your Freelance corner profile; this will give access to data that is on your public profile. Freelance corner does not share data with LinkedIn.

In addition to sign-up data, we store and collect all information associated with use of our products or postings. You should be aware that data shared in post creation may include metadata information such as the data and location a file or photo was created.

Please take note that the nature of the platform affords you the opportunity to share your location or planned location, this data is shared only in the format entered by yourself and in reference to the relevant tabs as selected by yourself. This data will be stored by Freelance Corner in the same way that all data is stored, it is your responsibility to ensure you have thought about your safety online and followed safety guidelines when sharing your location on the platform.

### **Sensitive data**

We may collect data on your opinions or political views, this is entirely as and when you desire, and Freelance Corner will only store the data in the location and format in which it is shared.

## HOW WE COLLECT DATA

6. We collect data in the following ways:
  - a. Data is given to us by you
  - b. Data is collected automatically
  - c. Data is provided about you by others

---

## DATA THAT IS GIVEN TO US BY YOU

7. We will collect your data in a number of ways, for example:
  - a. When you contact us through the website, by telephone, post, e-mail or through any other means
  - b. When you register with us and set-up an account to receive our products/services
  - c. When you complete surveys that we use for research purposes (although you are not obliged to respond to them)
  - d. When you enter a competition or promotion through a social media channel

- e. When you make payments to us, through this website or otherwise
- f. When you elect to receive marketing communications from us
- g. When you use our services

In each case, data will be collected in accordance with this privacy policy.

---

## DATA THAT IS COLLECTED AUTOMATICALLY

- 8. To the extent that you access the website, we will collect your data automatically, for example:
  - a. We automatically collect some information about your visit to the website. This information helps us to make improvements to the website content and navigation. This includes your IP address, the date, times and frequency with which you access the website, and the way you use and interact with its content.
  - b. We will collect your data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the website, see the section below headed "Cookies".

## OUR USE OF DATA

- 9. To the extent that others use our website and share data on you, for example:
  - a. Any posts that are independently posted but reference you or work you have collaborated on
  - b. Any responses to things you post by yourself
  - c. Photos shared by others

In all cases, all your data rights are preserved.

---

## OUR USE OF DATA

- 10. Any or all of the above data may be required by us from time to time in order to provide you with the best possible service and experience when using our website. Specifically, data may be used by us for the following reasons:
  - a. Internal record keeping
  - b. Improvement of our products/services
  - c. Transmission by email of marketing materials that may be of interest to you
  - d. Contact for market research purposes which may be done using email, telephone, fax or mail. Such information may be used to customize or update the website

In each case, data will be used in accordance with this privacy policy.

- 10. We may use your data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 11. For the delivery of direct marketing to you via e-mail, we will need your consent, whether via an opt-in or soft-opt-in:
  - a. Soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.
  - b. For other types of e-marketing, we are required to obtain your explicit consent. That is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.
  - c. If you are not satisfied about our approach to marketing, you have the right to withdraw consent at any time. To find out how to withdraw your consent, see the section headed "Your rights" below.

## WHO WE SHARE DATA WITH

13. We may share your data with the following groups of people for the following reasons:
  - a. Any of our group companies or affiliates – to ensure the proper administration of the services we provide to you;
  - b. Third party service providers who provide services to us which require the processing of personal data – to enable us to provide you with offers and services to help you get the best from our website and take advantage of any services we provide to you;
  - c. Third party payment providers who process payments made over the website – to enable third party payment providers to process user payments and refunds;
  - d. Relevant authorities – to facilitate the detection of crime;
  - e. Freelance Corner is Powered by IPSE and any data stored by one company may be accessible to the otherIn each case, in accordance with this privacy policy.

## KEEPING DATA SECURE

14. We will use technical and organisational measures to safeguard your data, for example:
  - a. Access to your account is controlled by a password and a username that is unique to you.
  - b. We store your data on secure servers.
15. Technical and organisational measures include measures to deal with any suspected data breach. ## DATA RETENTION

17. Unless a longer retention period is required or permitted by law, we will only hold your data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the data be deleted.
18. Even if we delete your data, it may persist on backup or archival media for legal, tax or regulatory purposes.

## YOUR RIGHTS

19. You have the following rights in relation to your data:
  - a. **Right to access** - the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with the access to information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. **Right to correct** - the right to have your data rectified if it is inaccurate or incomplete.
  - c. **Right to erase** - the right to request that we delete or remove your data from our systems.
  - d. **Right to restrict our use of your Data** - the right to "block" us from using your data or limit the way in which we can use it.

- e. **Right to data portability** - the right to request that we move, copy or transfer your data.
  - f. **Right to object** - the right to object to our use of your data including where we use it for our legitimate interests.

The new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the data for the purposes for which it was originally supplied to us.
25. We may also disclose data to a prospective purchaser of our business or any part of it.
26. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

## COOKIES

27. This website may place and access certain cookies on your computer. Freelance Corner uses cookies to improve your experience of using the website and to improve our range of services. Freelance Corner has carefully chosen these cookies and has taken steps to ensure that your privacy is protected and respected at all times.
28. All cookies used by this website are used in accordance with current UK and EU Cookie Law.
29. Before the website places cookies on your computer, you will be presented with a message bar requesting your consent to set those cookies. By giving your consent to the placing of cookies, you are enabling Freelance Corner to provide a better experience and service to you. You may, if you wish, deny consent to the placing of cookies; however certain features of the website may not function fully or as intended.

39. This agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
