

Membership agreement

ZPI is a spiritual community, which means, among other things, that how we say and do things is as important as what we say and do.

When we are grounded in the view that everything and everyone is One Body, with no exclusions and exceptions, there is a clear and natural implication that in all of us beats the one great heart of humanity.

To express and facilitate that, Zen Peacemakers International offers a unique package of value services to its members. To uphold and maintain these services:

1. Zen Peacemakers International reserves the right to change its services without prior notice.
2. ZPI Staff can revoke one's membership if according to their judgment an individual has violated the policies described in this document, whether it is on the Membership Platform, during a ZPI event or other relevant space, online or in-person. On that occasion, the revoked member can appeal the Administrator's decision and actions via an Appeal Process (below). If the Appeal Process ends with a ruling in their favor, their ZPI membership will be restored, as will all membership benefits. If one chooses not to appeal, or if the Process does not end with a ruling in their favor, the Administrator's decision will stand.
3. Members will not make statements on behalf of Zen Peacemakers International that is reserved to the staff of ZPI only.
4. Members are welcome to use the title 'Zen Peacemakers International, Member' as an individual, and not representing the whole.

Guidelines of Online Conduct

Expressing our opinions with consideration and respect for others is essential in our online comments, especially when we communicate with and about those we disagree with.

We recognize that online technology can facilitate fast, thoughtless replies, prompting us to react first and think later. When we see a story or comment that arouses strong antagonism, right there is an opportunity to practice with the Three Tenets. We return to the space of not-knowing, letting go of dogma and certainty, and bear witness to the strong feelings that arise in ourselves and others, remembering how different we all are as individuals from different countries and cultures, each with our unique conditioning and character. This

practice can give rise to communication that is wise and not incendiary, powerful rather than reactionary, and beneficial instead of causing harm.

The goal of the membership platform is to build bridges rather than cultivate division, and to let members freely air different views and opinions without being subject to bullying, harassment, or intimidation.

Please read Zen Peacemakers International's Rules of Online Conduct below and click *I Agree*.

1. I will communicate with others on the Membership Platform with respect and dignity regardless of their comments or opinions.
2. I will give special care to how I respond to those I disagree with, honoring the One Body and the spirit of the Three Tenets.
3. I will not engage in any form of cyber bullying or harassment of other members of the Membership Platform.
4. I will abstain from inflammatory, denunciatory, and threatening rhetoric, and I will not engage in verbally shaming and humiliating any member of the Membership Platform or their opinions.
5. I understand that the Membership Platform's Administrator can and will revoke my membership in the Membership Platform and expel me from its group of users if, in their judgment, I am violating these Rules of Online Conduct.
6. I also understand that, if that happens, I can appeal the Administrator's decision and actions via an Appeal Process (below). If the Appeal Process ends with a ruling in my favor, my membership in the Membership Platform will be restored, as will all membership benefits. I understand that if I choose not to appeal, or if the Process does not end with a ruling in my favor, the Administrator's decision will stand.

Appeals Process

In case the Administrator decides that a member of the Membership Platform has violated Zen Peacemaker International's Rules of Online Behavior, they can revoke that member's membership and all its benefits, including the use of the Platform. In that case the member can appeal the Administrator's decision in the following way:

They will have 60 days in which to appeal that decision to an Appeals Council, consisting of three members of the board of Zen Peacemakers International who have agreed to serve in this manner for a term of one year. An online meeting

will be arranged in which the Administrator will present their reasons for revoking the membership, and the aggrieved member can present why, in their view, the communication in question did not violate the Rules of Online Behavior.

The Appeals Council will issue a decision within 30 days of such meeting, which will serve as the final determination in such a case.

AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and **Zen Peacemakers International** ("we," "us" or "our"), concerning your access to and use of the **Membership Platform** website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site").
